# Data protection declaration (September 1st, 2023)

If you become member of the Society of Hair Testing (SoHT), only essential personal data are required, collected and stored in the membership database (Webling) allowing the data management of the association (membership status, member information, proficiency test organisation).

Webling is an online database for associations based in Switzerland. All data servers are located in Switzerland. Following data are stored in the database: Name, address, institution, email, telephone number, date of entry, payment dates without any information about credit card or bank relation.

Only SoHT board members have access to your data. Furthermore, data can be changed only by the president, the vice-president, the secretary and the treasurer of the SoHT.

Neither the SoHT nor uSystems GmbH (database provider, Klosterstrasse 3, 8406 Winterthur, Switzerland) forward data to any other company or third party. However, insofar as we are obliged to do so by law or by court order, we will transfer your data to bodies entitled to receive information.
